SC President Dave Hirst, who called the meeting to order with the poem "i am a little church" by e.e. cummings, sees us as "making decisions about change constantly."

The SC is in the process of making the position of the Treasurer more manageable, perhaps adding an assistant, and will turn to the congregation as needed—for that and any other hands-on help, with thanks to all the helping hands at NCC. # SOCIAL JUSTICE GROUP REPORT FEBRUARY 2013

**Toxic Charity Book Group:** The group began February 17 and will run to the end of March. For the last session, participants from the last group will be invited to attend. Because some have expressed interest in an additional book group, this request will be taken to the adult education group.

**NCC Survey:** In response to the survey, the group discussed the idea of an NCC directory which would include, among other things, NCC members' community involvement to show the wide range of activities with which our community is involved.

**IPA** ~ **Fracking:** Joe Boudreaux presented two minutes for mission on this issue and coordinated sending "valentines" to Gov. Quinn opposing fracking which had a good response from NCC members.

In early March, IPA held an action/lobbying day in Springfield to coincide with a workshop on fracking for County Board members from around the State.

There are plans to sponsor a Sunday movie night to show the movie "Gasland" followed by a discussion and an educational discussion night about fracking. Details will be announced as plans are finalized.

Alternatives to Payday Lending: Discussions continue with local banks about viable alternatives.

Book Bike: The need for books continues - especially board books, children's books and Spanish language books.

#### PARTNERS IN HEALING

NCC is a delegate congregation to Advocate BroMenn Medical Center. As part of that delegation, we participate in a project of intentional prayer for specific medical units associated with BroMenn on a rotating basis with other local congregations.

Each congregation is asked to pray for patients receiving medical care in a specific unit, as well as for the staff who are treating them and/or for their families for a month. NCC will be praying for the patients, family, and staff of the Outpatient Invasive Cardiology & Cardiac Catheterization Lab (OPICAR/CCL) at Advocate BroMenn Regional Medical Center for the month of March.

Advocate BroMenn's six-bed Outpatient Invasive Cardiology Unit serves patients undergoing cardiac catheterization procedures related to blood flow to the heart and other parts of the body. Many Cath Lab patients undergo angioplasty with stents, or small tubes, inserted to keep blocked arteries open, while others may need cardiac bypass surgery.


#### Our Life Song
